


# TopEfekt® PUNKT

## **Technical Data Sheet**





Specialistic product based on natural dissolvents and alcohols, designed for removing local impurities from markers insoluble in water, bubble gum, glue from self-adhesive labels, bitumen, rubber stains, plasticine, paraffin etc.

Warning: Dissolves rubber surfaces, soft plastic and non-original car paint.

#### **APPLICATION:**

- car bodies
- offices, houses, locker rooms, waiting rooms
- hard floors, carpet coverings

### **COMPOSITION:**

- < 50% alcohols
- 5-15% orange terpenes
- auxiliary components, not classified as dangerous.

### **USAGE:**

Read product's safety data sheet before using.

Use product without diluting.

Spray the contaminated spot on the surface, wait a moment and clean it with brush or cloth. In case of uneven surfaces, apply the product on the surface, wait a moment, brush it and collect the dirt with cloth

Warning: Before using, test the colour and surface durability. Do not use on rubber, soft plastic and acrylic glass.

#### **DANGER:**
