Product should not be used inside medical areas. Product is designed for using only inside closed areas (CIP)

# **Technical Data Sheet**

#### **USAGE:**

Before using, read product's safety data sheet.

Working solution must be made just before using it and only in ventilated rooms.

In case of full spectrum of the disinfecting substance (bactericidal, fungicidal, sporicidal, virucidal), spread the product on the surface with at least 2% concentration (200 ml / 10 l of water). It's best to use it in the form of the foam and in the temperature of 20°C. Working time: 15 minutes.

After disinfecting, wash down the surface with large amount of clean drinking water. Ventilate the room for 5 minutes after the whole operation.

Warning: Do not use with other products. May create harmful vapours (chlorine).

#### DANGER:



- Causes severe skin burns and eye damage.
- May cause respiratory irritation.
- Very toxic to aquatic life with long lasting effects.
- Wear protective gloves/protective clothing/eye protection/face protection.
- IF SWALLOWED: Rinse mouth. Do NOT induce vomiting.
- IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water [or shower].
- Immediately call a POISON CENTER/doctor
- IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

- Contact with acids liberates toxic gas.
